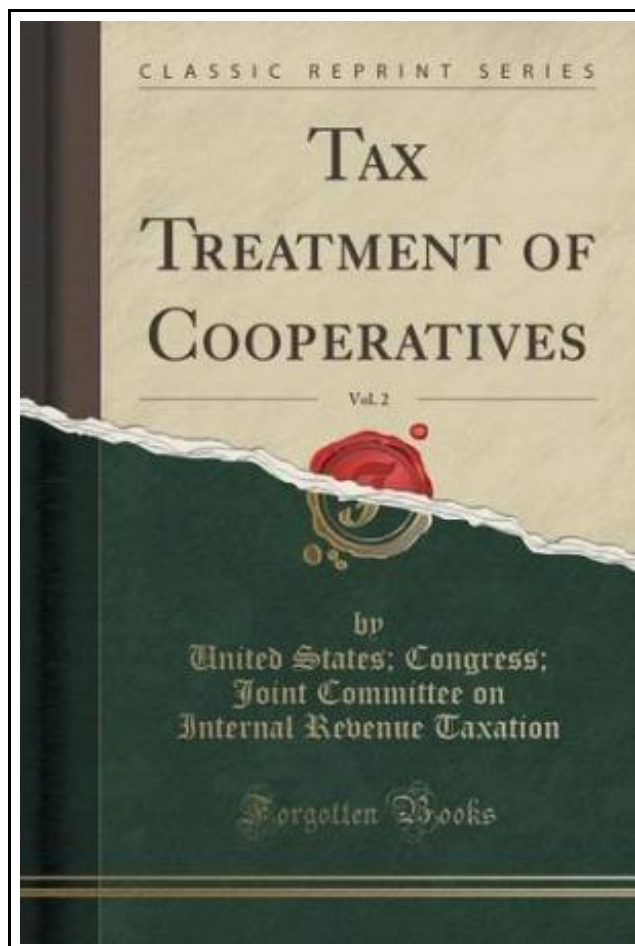

Cooperatives may be incorporated under State laws for the incorporation of ordinary business enterprises, but many States now have special statutes for the incorporation of cooperative corporations. The cooperative association, like any other corporation is an artificial entity created by law with a life independent of the people who own, manage, and do business with it. Moreover, like other incorporated enterprises organized to carry on some form of business activity, the cooperative, has a business purpose. For example, farm cooperatives exist to serve their farmer members and to increase the profits they derive from farming; and consumer cooperatives exist to reduce the expenses of their members. In this respect, the cooperatives differ from charitable and educational corporations whose primary functions are not directed to the economic advantage of their owners and organizers. Although cooperatives are in many ways similar to ordinary business corporations, there is one significant difference. The owners of the cooperatives are also their principal patrons. While most cooperatives issue capital stock, as do ordinary corporations, the dividends paid on such shares (and on preferred shares, if these are issued) are strictly limited. Unlike ordinary corporations, each member usually has only one vote, regardless of the number of shares he may own. There are many nonstock associations which issue membership certificates as evidences of residual equities in their assets. Whether the association is organized with...
